1 Terms and Conditions

- 1.1 Documentation. Your PORTL M purchase agreement is made up of the following documents: (i) PORTL Terms & Conditions; (ii) Software License Agreement; (iii) 1-Year Warranty; (iv) Privacy Policy; (v) Refund & Return Policy; (vi) Media Services & EULA; and the following terms and conditions set forth herein.

PORTL reserves the right, in its sole discretion, to limit order quantity, refuse or cancel orders above the limit and cancel a preorder at any time for any reason. You will receive a deposit refund if PORTL cancels your order. If you decide to terminate your order, you may be liable for termination fees or other charges to PORTL. Making unauthorized modifications to the software on a PORTL M violates PORTL's Software License Agreement and the inability to use the PORTL M due to unauthorized software modifications is not covered under warranty. Further, any such modification may render your PORTL M inoperable and void your warranty.

Please note that the final design, specifications and functionality of the PORTL M are subject to change.

2 Placing Your Order

- 2.1 To place an order you must be 18 years of age or over. PORTL reserves the right to cancel your order in its absolute discretion if we should determine that you are not 18 years of age or over or if the device will not be used in accordance with the Terms and Conditions. We will inform you if we cancel your order on the above basis. Any payments you have made will be refunded to you.
- 2.2 You may place an order by filling in the order form on the PORTL web site after creating your personal account and clicking on the "place my order" button" or by contacting PORTL and ordering through a representative.
- 2.3 PORTL will not accept orders in any way other than that listed above.
- 2.4 When you place your order, we will issue you with a web order number. We will do this via the PORTL web site, unless you have placed an order through a PORTL representative, in which case we will issue your web order number when you contact us.
- 2.5 By placing an order, you make an offer to us to purchase the products you have selected on these Terms & Conditions along with PORTL's Terms & Conditions set forth on www.portlhologram.com. We may or may not accept your offer at our discretion.
- 2.6 If we accept your order, we will notify you of our acceptance by issuing an order confirmation. We will send your order confirmation to you by email provided you have indicated an email address when ordering.
- 2.7 We will make every effort to supply you with the products listed on the order confirmation and there may be occasions where we are unable to supply these products because we are unable to source relevant components or are unable to supply the products due to demand. In such circumstances, we will contact you to inform you of the delay and anticipated delivery times.
- 2.8 You are limited to 5 PORTL M units per purchase order.

3 Supply of Your Products

- 3.1 Subject to these terms and conditions, we will supply to you the products indicated on your order confirmation.

4 Prices

- 4.1 The price for the products will be the price indicated on your invoice.
- 4.2 Delivery costs, where applicable, are payable by you as indicated on your invoice.

5 Paying for your Products

- 5.1 You may pay for your products by the methods of payment as may be displayed on the payment section of the PORTL website and in USD.
- 5.2 If you are paying by credit card, then you must supply your credit card details when you place your order. Your credit card will be charged when we issue your invoice or on shipment of your products. We will not commence the manufacture of your products neither will we supply the products to you nor perform the services until your credit card issuer has authorized the use of your card for payment of the products ordered. We will let you know if we do not receive credit card authorization.

6 Delivery of Your Products

- 6.1 We will deliver your products to the delivery address as shown on your order form.
- 6.2 We will use our reasonable endeavors to manufacture and deliver your products to you within 45 days of the date of issue of your order confirmation. Estimated product build times are given at the time of placing the order are estimates only and do not equate to delivery times. If you have ordered several products at one time, we may deliver such products on different dates.
